## Entry Sheet - Risk Warning

Participants are warned that regardless of precautions that might be taken by reasonable and experienced persons, power boating events can be dangerous and participants are exposed to significant risk of property damage, physical injury and possibly death.

As an indication these risks may include but are not limited to:

- The extremes of weather and river conditions.
- The potential that control of boat may be lost, resulting from collision with other boats or objects in water.
- The potential of fire or explosion.
- The possibility of accident resulting in being thrown overboard or trapped resulting in drowning.
- The absence of immediate medical care, and the possibility that significant delays may occur before medical help is available.

The Motor Yacht Club of Tasmania also warn participants that regardless of their best intentions, they may be unable to render assistance to participants who are in distress or who's property is in danger of being lost. Participants are warned to consider the above risks and all other risks before deciding to participate in this event.

Participants are also advised that the insurance obtained by the Motor Yacht Club of Tasmania is third party liability cover and does not extend to any participant. Any participant who considers they have need for insurance must make their own private arrangements with an insurer.
